**“A RESOLUTION DECLARING MATROSON BUILDERS & ENGINEERING SERVICES AS THE WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF MULTI-LAYER STORAGE RACK FOR PGSO WAREHOUSE USE WITH AN AMOUNT OF TWO MILLION FIVE HUNDRED FORTY THREE THOUSAND TWO HUNDRED FORTY PESOS (PHP2,543,240.00)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Supply, Delivery and Installation of Multi-layer Storage Rack for PGSO Warehouse use is **TWO MILLION FIVE HUNDRED FORTY FOUR THOUSAND TWO HUNDRED EIGHTY ONE PESOS (PHP2,544,281.00)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **September 8, 2021**;

**WHEREAS**, the bid opening was conducted on **September 30, 2021** and the complying bidder was **Matroson Builders & Engineering Services**;
