“A RESOLUTION DECLARING NDP CONSTRUCTION DEVELOPMENT AS THE WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE CONCRETING OF MAGSAYSAY-LUMBAC PROVINCIAL ROAD (STA. 4+942.64-STA. 5+070.68 – STA. 5+328.00 – STA. 5+700.00; STA. 5+922.60 – STA. 6+500.00) WITH AN AMOUNT OF TWENTY NINE MILLION NINE HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED TWO PESOS AND NINETY SEVEN CENTAVOS (29,998,202.97)”

WHEREAS, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

WHEREAS, the approved budget for the Concreting of Magsaysay-Lumbac Provincial Road (Sta. 4+942.64 – Sta. 5+070.68; Sta. 5+328.00 – Sta. 5+700.00; Sta. 5+922.60 – Sta. 6+500.00) is **THIRTY MILLION PESOS (PHP30,000,000.00)** as certified by the Provincial Accountant;

WHEREAS, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **May 24, 2022**;

WHEREAS, the bid opening was conducted on **June 23, 2022** and the complying bidder was **NDP Construction Development**;
