**“A RESOLUTION DECLARING ZAIN CONSTRUCTION AS THE WINNING BIDDER, THEREBY,  
RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE RENOVATION  
OF ISOLATION BUILDING AT SULTAN NAGA DIMAPORO PROVINCIAL HOSPITAL WITH AN  
AMOUNT OF FOUR MILLION NINETY FOUR THOUSAND SEVEN HUNDRED THIRTY NINE  
PESOS AND EIGHTY THREE CENTAVOS (PHP4,094,739.83)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Renovation of Isolation Building at Sultan Naga Dimaporo is **FOUR MILLION NINETY SEVEN THOUSAND SEVEN HUNDRED FORTY PESOS AND SIXTY ONE CENTAVOS (PHP4, 097,740.61)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **June 8, 2022**;

**WHEREAS**, the bid opening was conducted on **July 7, 2022** and the complying bidder was **Zain Construction**;
