**“A RESOLUTION DECLARING PAPUMAMU ENTERPRISES AS THE WINNING BIDDER,
THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE
SUPPLY AND DELIVERY OF CUSTOMIZED SHIRT FOR 8TH PROVINCIAL EMERGENCY
RESPONSE UNIT CONGRESS WITH AN AMOUNT OF FOUR MILLION ONE HUNDRED SIX
THOUSAND NINE HUNDRED SIXTY SEVEN PESOS AND FORTY SIX CENTAVOS
(PHP4, 106,967.46)”**

WHEREAS, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

WHEREAS, the approved budget for Supply and Delivery of Customized Shirt for 8th Provincial Emergency Response Unit Congress is **FOUR MILLION ONE HUNDRED SEVEN THOUSAND ONE HUNDRED FIFTY PESOS (PHP4,107,150.00)** as certified by the Provincial Accountant;

WHEREAS, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **March 23, 2022**;

WHEREAS, the bid opening was conducted on **April 21, 2022** and the complying bidder was **Papumamu Enterprises**;
