“A RESOLUTION DECLARING DICON BUILDERS CORP. AS THE WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE CONSTRUCTION OF TENNIS COURT/VOLLEYBALL COURT WITH BLEACHERS @ PROVINCIAL CAPITOL COMPOUND WITH AN AMOUNT OF NINE MILLION ONE HUNDRED SEVENTY SEVEN THOUSAND NINE HUNDRED SIXTY THREE PESOS AND EIGHTY SEVEN CENTAVOS (PHP9,177,963.87)”

WHEREAS, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

WHEREAS, the approved budget for the Construction of Tennis Court/Volleyball Court with Bleachers @ Provincial Capitol Compound is **NINE MILLION ONE HUNDRED NINETY SIX THOUSAND PESOS (PHP 9,196,000.00)** as certified by the Provincial Accountant;

WHEREAS, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **February 11, 2022**;

WHEREAS, the bid opening was conducted on **March 10, 2022** and the complying bidder was **Dicon Builders Corp.**;
