CONTRACT AGREEMENT

THIS AGREEMENT, made this 23rd day of December 2021 between HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte hereinafter called the "ENTITY" and Mr. NORODIN D. PUNDAMUDAG, Proprietor/Manager, of NDP CONSTRUCTION DEVELOPMENT, Marawi City, Lanao del Sur hereinafter called the "CONTRACTOR".

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract: **CONCRETING OF MATUNGAO-BALOI PROVINCIAL ROAD. (STA.2+260.00-STA.2+731.55; STA 2+913.54-STA.3 + 060.00) located at Matungao & Baloi, Lanao del Norte,** hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **FOURTEEN MILLION EIGHT HUNDRED FORTY THREE THOUSAND SEVEN HUNDRED EIGHTY SIX PESOS AND TWENTY ONE CENTAVOS (PhP 14,843,786.21) only** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within **One Hundred Fifty Nine (159) calendar days.**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
