CONTRACT AGREEMENT

THIS AGREEMENT, made this 14th day of October 2021 between **HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte** hereinafter called the "ENTITY" and **MR. AQUIL LANTO MACAGAAN, Proprietor/Manager, MOYA CONSTRUCTION** located at Lomindong, MSU, Marawi City Lanao del Sur hereinafter called the "CONTRACTOR".

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract **CONSTRUCTION OF PROVINCIAL GRAIN PROCESSING CENTER (PGPC) GARAGE AND WAREHOUSE** located at Kapatagan Lanao del Norte, hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **ONE MILLION NINE HUNDRED SIXTY NINE THOUSAND NINE HUNDRED SIXTY-SEVEN PESOS AND 14/100 ONLY (Php 1,969,967.14)** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within be **Sixty (60)** calendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this CONTRACT AGREEMENT, to wit:

- (a) General and Special Conditions of Contract;
- (b) Drawings/Plans;
- (c) Specifications;
- (d) Invitation to Bid;
- (e) Instructions to Bidders;
- (f) Bid Data Sheet;
- (g) Addenda and/or Supplemental/Bid Bulletins, if any;
- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, and all other documents submitted including the Bill of Quantities as stipulated by Procuring Entity;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conformed thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.
- (m) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this CONTRACT AGREEMENT in all respects.
