**CONTRACT AGREEMENT**

 THIS AGREEMENT, made this 23rd day of November 2021 between **HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte** hereinafter called the "ENTITY" and **SULTAN BAGUAN M. MAMISCAL, Proprietor/Manager, BRIMA CONSTRUCTION AND ENTERPRISES, 0054 Oxford Street, Celdran Village, Tubod, Iligan City** hereinafter called the "CONTRACTOR".

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract: the **Concreting of Lala Gumagamot Provincial Road (Sta.3+443.03-sta 3+698.63) Project Location: Lala, Lanao del Norte**, hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **FOUR MILLION NINE HUNDRED EIGHTY THREE THOUSAND TWO HUNDRED THREE PESOS AND EIGHT SIX CENTAVOS (PhP 4,983,203.86) only** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within **Seventy Two (72) calendar days**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
