Pursuant to the findings and recommendations of the Bids and Awards committee (BAC) Resolution No. _____, S.2021, we are glad to notify that the contract for the implementation of the **COMPLETION OF WATER LABORATORY ROOM AT PROVINCIAL HEALTH OFFICE** located at Pigcarangan, Tubod, Lanao del Norte is hereby awarded to you as the Bidder with the Single Calculated Responsive Bid (SCRB) at a contract price equivalent to **EIGHT HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS AND EIGHTY SEVEN CENTAVOS (PhP 896,877.87) only**. a) Bank draft/guarantee or irrevocable Letter Letter of Credit issued by a Universal of Commercial Bank: <i>Provided, however, that</i> is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank	10%
a) Surety Bond callable upon demand issued by a surety or insurance company duly Certified by the Insurance Commission as authorized to issue such security	30%
