WHEREAS, the Entity is desirous that the Contractor execute the works under Contract: *Concreting of Magsaysay-Lumbac Provincial Road (Sta. 4+942.64 – Sta. 5+070.68; Sta. 5+328.00 – Sta. 5+700.00; Sta. 5+922.60-Sta. 6+500.00 located at Lumbac ,Magsaysay, Lanao del Norte,* hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **TWENTY NINE MILLION NINE HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED TWO PESOS AND NINETY SEVEN CENTAVOS (PhP 29,998,202.97) only** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within **197 calendar days (including Saturday, Sunday and 40 predetermined unworkable days).**
