**“A RESOLUTION DECLARING MATROSON BUILDERS AND ENGINEERING SERVICES AS THE  
WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF  
CONTRACT FOR THE CONSTRUCTION OF LAUNDRY BUILDING AND MISCELLANEOUS  
STRUCTURES OF LNPH WITH AN AMOUNT OF TWO MILLION FIVE HUNDRED FIFTY EIGHT  
THOUSAND THREE HUNDRED FORTY SIX PESOS AND SIXTY EIGHT CENTAVOS  
(PHP2,558,346.68)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Construction of Laundry Building and Miscellaneous Structures of LNPH is **TWO MILLION FIVE HUNDRED FIFTY NINE THOUSAND THREE HUNDRED EIGHTEEN PESOS AND FORTY SEVEN CENTAVOS (PHP2, 559,318.47)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) **published** the abovementioned item in PhilGeps and Local Bulletin Board on **August 23, 2022**;
