**CONTRACT AGREEMENT**

 THIS AGREEMENT, made this 19<sup>th</sup> day of July 2022 between **HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte** hereinafter called the "ENTITY" and **SULTAN BAGUAN M. MAMISCAL, Proprietor/Manager, BRIMA CONSTRUCTION AND ENTERPRISES, 0054 Oxford Street, Celdran Village, Tubod, Iligan City** hereinafter called the "CONTRACTOR".

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract: **Construction of slope protection structures along Liangan-Camp I-Mahayahay Provincial road (Sta. 2+240.00 – Sta. 2+248.00, Sta. 2+913.54 – Sta. 2+498.10) Project Location: Barangay Camp 1, Maigo, Lanao del Norte**, hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **THREE MILLION NINE HUNDRED NINETY SIX THOUSAND NINE HUNDRED EIGHTY PESOS AND SIXTY THREE CENTAVOS (PhP 3,996,980.63) only** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within **117 calendar days (including Saturday, Sunday and 24 predetermined unworkable days)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this CONTRACT AGREEMENT, to wit:

Bidding Documents for the Contract (Annex "A")

- (a) General and Special Conditions of Contract;
- (b) Drawings/Plans;
- (c) Specifications;
- (d) Invitation to Bid;
- (e) Instructions to Bidders;
- (f) Bid Data Sheet;
- (g) Addenda and/or Supplemental/Bid Bulletins, if any;
- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, and all other documents submitted including the Bill of Quantities as stipulated by Procuring Entity;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conformed thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.
- (m) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this CONTRACT AGREEMENT in all respects.
