**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 25th day of August 2022 between HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte hereinafter called the "ENTITY" and SULTAN BAGUAN M. MAMISCAL, Proprietor/Manager, BRIMA CONSTRUCTION AND ENTERPRISES, 0054 Oxford Street, Celdran Village, Tubod, Iligan City hereinafter called the "CONTRACTOR"..

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract: **Improvement of Lala-Market-Dunggoan Provincial road (Sta. 4+420.00 – STA. 5+580.00) Project Location: Lala, Lanao del Norte,** hereinafter called "the Works" and the ENTITY has accepted the Calculated Bid of **TWENTY NINE MILLION NINE HUNDRED NINETY FOUR THOUSAND SIX HUNDRED NINETY FIVE PESOS AND THIRTY SEVEN CENTAVOS (Php 29,994,695.37) only** of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within **202 calendar days (including Saturdays, Sundays, and 40 Predetermined Unworkable Days).**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this CONTRACT AGREEMENT, to wit:

Bidding Documents for the Contract (Annex "A")

- (a) General and Special Conditions of Contract;
- (b) Drawings/Plans;
- (c) Specifications;
- (d) Invitation to Bid;
- (e) Instructions to Bidders;
- (f) Bid Data Sheet;
- (g) Addenda and/or Supplemental/Bid Bulletins, if any;
- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, and all other documents submitted including the Bill of Quantities as stipulated by Procuring Entity;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conformed thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.
- (m) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this CONTRACT AGREEMENT in all respects.
