THIS AGREEMENT, made this 10<sup>th</sup> day of October between **HON. IMELDA QUIBRANZA-DIMAPORO, Provincial Governor, Gov. Arsenio A. Quibranza Provincial Government Center, Pigcarangan, Tubod, Lanao del Norte** hereinafter called the "ENTITY" and **MR. ERNESTO F. FLORENTINO, Green-GAIA Technology Development and Construction, OPC** located at Davao City hereinafter called the "CONTRACTOR"..

WHEREAS, the Entity is desirous that the Contractor execute the works under Contract for **Proposed 250 cubic meter sewage treatment plant at Lanao Del Norte Provincial Hospital** located at Baroy, Lanao del Norte is hereby awarded to you as the Bidder with the Single Calculated Responsive Bid (SCRB) at a contract price equivalent to **FOURTEEN MILLION NINE HUNDRED NINETY SIX THOUSAND FIVE HUNDRED EIGHT PESOS AND THIRTY THREE CENTAVOS (PhP 14,996,508.33) only**.of the CONTRACTOR for the execution and completion of such works and remedying of the defects therein within be **One Hundred Eighty (180)** calendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this CONTRACT AGREEMENT, to wit:

- (d) Invitation to Bid;
- (e) Instructions to Bidders;
- (f) Bid Data Sheet;

- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, and all other documents submitted including the Bill of Quantities as stipulated by Procuring Entity;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conformed thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.
- (m) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the Works and remedy any defects therein in conformity with the provisions of this CONTRACT AGREEMENT in all respects.

4. In consideration of the execution and completion of the Works by the CONTRACTOR, the ENTITY hereby covenants to pay the CONTRACTOR the unit in the CONTRACTOR's Calculated Bid, as applied to the actual quantities accomplished as certified by the PROCURING ENTITY under the provisions of this CONTRACT AGREEMENT, at the times and in the manner prescribed by this CONTRACT AGREEMENT.
