Pursuant to the findings and recommendations of the Bids and Awards committee (BAC) Resolution No. _____, S.2022, we are glad to notify that the contract for the implementation of the **Construction of slope protection structures along Liangan-Camp I-Mahayahay Provincial road (Sta. 2+240.00 – Sta. 2+248.00, Sta. 2+913.54 – Sta. 2+498.10) Project Location: Barangay Camp 1, Maigo, Lanao del Norte** is hereby awarded to you as the Bidder with the Single Calculated Responsive Bid (SCRB) at a contract price equivalent to **THREE MILLION NINE HUNDRED NINETY SIX THOUSAND NINE HUNDRED EIGHTY PESOS AND SIXTY THREE CENTAVOS (PhP 3,996,980.63) only**. a) Bank draft/guarantee or irrevocable Letter Letter of Credit issued by a Universal of Commercial Bank: <i>Provided, however</i> , that is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank	10%
a) Surety Bond callable upon demand issued by a surety or insurance company duly Certified by the Insurance Commission as authorized to issue such security	30%

Failure to enter into the said contract or provide the Performance Security shall constitute a sufficient ground for cancellation of this award and forfeiture of your Bid Security.
