


The Provincial Government of Lanao del Norte - Inventory, Appraisal, and Disposal Committee (PGLDN-IADC), invites interested parties within Lanao del Norte to bid for the Sale and Disposal of various unserviceable Light and Heavy Equipment described below located at the Asphalt Plant, Balagatasa, Maigo, Lanao del Norte, on an “**As Is, Where Is**” basis to wit:

1. Upon payment of non-refundable Bid Fee of One Thousand Pesos (Php1,000.00) to the Provincial Treasurer’s Office - Cashiering Division, qualified bidders may get the bid documents at the Office of the Provincial Services - Property Section, view and inspect said scrap light and heavy equipment at said location on October 17-21, 2022.

Only the perspective bidder or his duly authorized representative shall be allowed during the viewing.

2. Sealed bids will be received at Office of the Provincial General Services, Lanao del Norte - Inventory, Appraisal, and Disposal Committee (IADC) Secretariat (Inventory Section) on or before 01:00 P.M. of 21 October 2022 (Friday). The bidder shall enclose in a sealed envelope the following:
 - a. Fully-accomplished Bid Form
 - b. Minimum bond equivalent to ten (10% percent) or more of the bid in the form of cash or manager's check issued by a reputable bank payable to the "Provincial Government of Lanao del Norte."
 - c. Photocopy of the bidder's latest and valid Mayor's/Business Permit; In case of submission of the expired permit, the official receipt will be acceptable as proof that the bidder has applied for the renewal of the Mayor's/Business Permit
 - d. Photocopy of the bidder's latest Annual Income Tax Return (BIR Form 1701), stamped "received by BIR or its duly accredited and authorized Institutions"/Tax Clearance (BIR Form 17.14B) or Certificate of Registration (BIR Form 2303), in case of new companies.
 3. Deadline for submission of sealed bids is on October 21, 2022 at 1 P.M. Late bids shall not be accepted. The Opening of Sealed Bids shall commence at 1:30 P.M. of the same day.
 4. The bidder or his/her duly authorized representative must be present during the opening of the bids; otherwise, his/her envelope shall not be opened. They are also required to wear proper attire (slippers, sando, shorts, and rugged jeans are not allowed) when entering the Capitol Building.
 5. The bid shall be declared void if it does not comply with the requirements mentioned in item 1, 2, 3, and 4. Prior to the issuance of the Notice of the Award and the Proceed (NAP), the winning bidder shall present the original copy of the foregoing documents for validation on the day of the opening of bids.
 6. The bond will be returned to the non-winning bidder/s right after the award.
 7. The ten percent (10%) bond shall be forfeited if the full price is not paid by the winning bidder within the prescribed period stated in NAP.
 8. The winning bidder shall be informed by the Provincial Government of Lanao del Norte - Inventory, Appraisal, and Disposal Committee (PGLDN-IADC) through a **Letter of Notice of Award**. Payment per withdrawal must be made by the winning bidder (highest bidder) to the Provincial Government of Lanao del Norte - Treasurer's Office (PGLDN-PTO) on the same day of withdrawal.
 9. In the event that the winning bidder fails to remove the said scrap items located at Asphalt Plant, Balagatasa, Maigo, Lanao del Norte within ninety days (90) days, the award given shall be canceled, and the scrap items shall be made available to the next highest bidder.
 10. The Provincial Government of Lanao del Norte - Inventory, Appraisal, and Disposal Committee (PGLDN-IADC) warns that collusion among bidders or with a Provincial Government of Lanao del Norte (PGLDN) official or employee to defraud the government



shall be dealt with accordingly.

11. This invitation shall be posted / advertised in the PGLDN website and bulletin board of the Province of Lanao del Norte.
12. The Provincial Government of Lanao del Norte - Inventory, Appraisal, and Disposal Committee (PGLDN-IADC) reserves the right to reject any or all bids, to waive any defects or informality of the bid received, to accept the bid most advantageous to the Provincial Government of Lanao del Norte, and that this office does not guarantee that an award will be made. The decision of the Provincial Government of Lanao del Norte - Inventory, Appraisal, and Disposal Committee (PGLDN-IADC) in this regard shall be final and binding.
