**“A RESOLUTION DECLARING KOUZBARY BUILDERS AS THE WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE REHABILITATION AND CONSTRUCTION OF FLOOD CONTROL AT MALABANG-MASIBAY-MAITOMAIG (KAPATAGAN-SAPAD) PROVINCIAL ROAD KAPATAGAN, LANA DEL NORTE STA. 06+938.00 – Sta. 8+895.50 (PCCP); Sta. 0+180.00 –Sta. 0+75 WITH AN AMOUNT OF FORTY NINE MILLION NINE HUNDRED FIFTY THOUSAND FOUR HUNDRED THIRTY TWO PESOS AND NINETY CENTAVOS (PHP49,950,432.90)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Rehabilitation and Construction of Flood Control at Malabang-Masibay-Maitomaig (Kapatagan-Sapad) Prov'l. Road Kapatagan, Lanao del Norte Sta. 06+938.00 – Sta. 8+895.50 (PCCP); Sta. 0+180.00 – Sta. 0+75 is **FIFTY MILLION PESOS (PHP50,000,000.00)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhjIGeps and Local Bulletin Board on **September 8, 2022**;
