**“A RESOLUTION DECLARING CUDAL PRESS AS THE WINNING BIDDER, THEREBY,  
RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE PROCUREMENT OF  
CHILDREN’S EDUCATIONAL MATERIALS KIT FOR PROVINCIAL CHILDREN’S CONGRESS WITH  
AN AMOUNT OF ONE MILLION NINE HUNDRED NINETY THREE THOUSAND TWO HUNDRED  
FIFTY PESOS (PHP1,993,250.00)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Procurement of Children’s Educational Materials Kit for Provincial Children’s Congress is **ONE MILLION NINE HUNDRED NINETY FIVE THOUSAND PESOS (PHP1,995,000.00)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **September 21, 2022**;

**WHEREAS**, the bid opening was conducted on **October 13, 2022** and the complying bidder was **Cudal Press**;

**WHEREAS**, after post evaluation by the TWG, it was validated, verified and ascertained that **Cudal Press** has complied with all the legal, technical and financial requirements to qualify as an eligible bidder with the bid price as calculated in the amount of **ONE MILLION NINE HUNDRED NINETY THREE THOUSAND TWO HUNDRED FIFTY PESOS (PHP1,993,250.00)**;
