“A RESOLUTION DECLARING LR ENTERPRISES AS THE WINNING BIDDER, THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE PROCUREMENT OF VARIOUS MEDICAL, DENTAL AND LABORATORY SUPPLIES FOR 6 PROVINCIAL HOSPITALS FOR 2ND SEMESTER CY 2022 WITH AN AMOUNT OF FOURTEEN MILLION ONE HUNDRED TEN THOUSAND SEVEN HUNDRED TWENTY EIGHT PESOS AND SIXTY CENTAVOS (PHP14,110,728.60)”

WHEREAS, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

WHEREAS, the approved budget for the Procurement of Various Medical, Dental and Laboratory Supplies for 6 Provincial Hospitals for 2nd Semester CY 2022 is **FOURTEEN MILLION ONE HUNDRED FORTY ONE THOUSAND NINE HUNDRED NINETY EIGHT PESOS AND SIXTY CENTAVOS (PHP14,141,998.60)** as certified by the Provincial Accountant;

WHEREAS, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PhilGeps and Local Bulletin Board on **September 21, 2022**;
