Pursuant to the findings and recommendations of the Bids and Awards committee (BAC) Resolution No. S.2022, we are glad to notify that the contract for the implementation of the **Rehabilitation and construction of flood control at Malabang-Masibay-Maitomaig (Kapatagan-Sapad) Prov'l Road Kapatagan, Lanao del Norte Sta. 06+938.00 – Sta. 8+895.50 (PCCP); Sta. 0+180.00 – Sta. 0+75 located at Kapatagan, Lanao del Norte** is hereby awarded to you as the Bidder with the Single Calculated Responsive Bid (SCRB) at a contract price equivalent to **FORTY NINE MILLION NINE HUNDRED FIFTY THOUSAND FOUR HUNDRED THIRTY TWO PESOS AND NINETY CENTAVOS (Php 49,950,432.90) only**. The contract completion shall be **256 calendar days (including Saturday, Sunday and 48 predetermined unworkable days)** from date of receipt of the Notice to Proceed.

You are therefore required, within ten (10) calendar days from the receipt of this Notice, to formally enter into a contract with us, and to submit any form of Performance Security in the amount stipulated in the instruction to Bidders, as follows:

a) Cash or Letter of credit issued by Universal Or Commercial Bank: provided, however, that the letter of credit shall be confirmed or Authenticated by a Universal or Commercial Bank, if issued by a foreign bank	5%
b) Bank draft/guarantee or irrevocable Letter Letter of Credit issued by a Universal of Commercial Bank: <i>Provided, however, that</i> is shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank	10%
c) Surety Bond callable upon demand issued by a surety or insurance company duly Certified by the Insurance Commission as authorized to issue such security	30%


Failure to enter into the said contract or provide the Performance Security shall constitute a sufficient ground for cancellation of this award and forfeiture of your Bid Security.
