**“A RESOLUTION DECLARING CHARMMED INCORPORATED AS THE WINNING BIDDER,  
THEREBY, RECOMMENDING THE SAME FOR THE AWARDING OF CONTRACT FOR THE  
PROCUREMENT OF VARIOUS DRUGS AND MEDICINES FOR 6 PROVINCIAL HOSPITALS FOR  
2<sup>ND</sup> SEMESTER CY 2022 (NON VAT) WITH AN AMOUNT OF ONE MILLION FIVE HUNDRED  
EIGHTEEN THOUSAND FOUR HUNDRED THREE PESOS AND SEVENTY CENTAVOS  
(PHP1,518,403.70)”**

**WHEREAS**, the principle of government procurement requires transparency in the procurement process and in the implementation of procurement contracts, equal opportunity shall be extended to private contracting parties who are qualified and eligible to participate in public bidding. Moreover, in the implementation of awarded contracts, it shall be conducted with the end view of guaranteeing that these contracts are awarded pursuant to the provisions of R.A. 9184 and its implementing rules and regulations;

**WHEREAS**, the approved budget for the Procurement of Various Drugs and Medicines for 6 Provincial Hospitals for 2<sup>nd</sup> Semester CY 2022 (Non VAT) is **ONE MILLION FIVE HUNDRED TWENTY SIX THOUSAND TWO HUNDRED FIFTY TWO PESOS AND FIVE CENTAVOS (PHP1,526,252.05)** as certified by the Provincial Accountant;

**WHEREAS**, pursuant to Section 2 of the IRR of RA No. 9184, otherwise known as the Government Procurement Reform Act, and in consonance with the competitiveness and transparency principles, the Bids and Awards Committee (BAC) published the abovementioned item in PFIIGeps and Local Bulletin Board on **October 5, 2022**;
